In case the candidate is not able to clear in the first attempt, then a resit can be booked where the resit fee will be charged; the resit should ideally be done/passed before the study text expires.
- Closing date for **October 2019** CII examination for all applications / entry to reach PII is **9 August 2019**.
- All payments should be made in the form of Pay order / Demand Draft in favour of Pakistan Insurance Institute, Karachi.

- **In view of the recent fluctuations in the exchange rate the difference if any, shall be charged from the candidate.**
- **Any difference in the amount invoiced by CII will be collected from the candidate.**

**EXAMINATION HALL REQUIREMENT**
